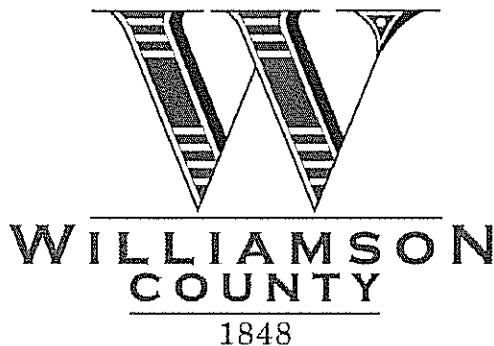


**Automatic Bank Draft Authorization Form
Over 65/Disabled
Quarterly Payments**



Sec 31.031 of the Property Tax Code allows individuals who have a valid Disabled or Over 65 years of age exemption, AND a qualified general homestead exemption on file with the Williamson Central Appraisal District to choose an installment payment option on the property in which homestead is claimed. Written notification (**this form will suffice**) and the first quarter installment must be received by January 31st in order to activate this option. Those who qualify will have their quarterly payments drafted on March 15th, May 15th, and July 15th in accordance with this agreement.
