

# JUSTICE COURT NOTICE

This letter is furnished as a courtesy to you by the Justice Courts of Williamson County, Texas

to assist you in processing the charge(s) against you.

PLEASE NOTE: The Judge cannot discuss the merits of a pending judicial proceeding prior to trial (*Canon 6 (c*)(2) Code of Judicial Conduct). <u>This means the Judge cannot discuss your citation/ticket with you before the trial.</u>

 If you wish to ENTER A PLEA OF GUILTY OR NOLO CONTENDERE, please indicate by checking #1 or #2 on the reverse side of this plea form. A plea of Nolo Contendere means that you do not contest the state's charge(s) against you. The fine and conviction for a Nolo Contendere plea is the same as that for a plea of Guilty.

Refer to the schedule shown on the reverse side to determine the total amount of fine(s) and costs acceptable by the Court. These fines <u>apply only</u> to cases handled <u>prior to Court trial</u> or <u>Judgment being entered</u>.

RETURN A COPY OF THE CITATION/TICKET AND THIS LETTER WITH YOUR PAYMENT TO ASSURE PROPER CREDIT.

- 2. If you wish to enter a plea of NOT GUILTY and desire a trial, advise the Court by checking #3 or #4 on the plea form <u>on or before the appearance date</u>. You will be notified by the Court when to appear for trial and specific requirements of the particular Court concerning bail requirements, etc. If you should change your mailing address prior to receiving notice to appear in Court for your trial, it is your responsibility to notify the Court in writing of your new mailing address.
- 3. DRIVING SAFETY COURSE AS A CONDITION OF DEFERRED DISPOSITION: please indicate by checking #5 on the reverse side of this plea form. Under the laws of the State of Texas, you may be able to require that this (one) charge be dismissed by successfully completing a Driving Safety Course. HOWEVER, you will lose that right if you do not provide written notice and a plea of Guilty or Nolo Contendere to the Court <u>on or before the</u> <u>appearance date</u> (as shown on your citation).

If you FAIL TO RESPOND to the charge(s) BY THE APPEARANCE DATE SHOWN ON THE CITATION/TICKET, an additional charge may be filed against you for Violate Promise to Appear/Failure to Appear and warrants issued for your arrest.

WARRANT FEES OF \$50.00 will be added onto each charge for EXECUTING OR PROCESSING A WARRANT.
