

If not within a recorded subdivision, and the property is from 0-5 acres within the city limits or an Extraterritorial jurisdiction (ETJ) of a city; applicant should provide a letter from the city platting authority qualifying the lot as exempt from required platting. Properties in Williamson County but not within the city limits or ETJ will need a platting exemption from the county engineer's office if the property is less than 10 acres and the property was not conveyed as a "gift deed".

To determine if property is within an ETJ you can use the Williamson County GIS "Address Search" at <https://gis.wilco.org/search/> or attached ETJ map.
