D. One passport-sized photograph of Applicant.
E. One full set of Applicant's fingerprints to be placed on file with the Williamson County Sheriff's Office. If this is a renewal application, the fingerprint card currently on file with the Sheriff's Office will be sufficient.
F. Certified copy of Applicant's criminal history provided by the Texas Department of Public Safety on forms obtained from that office.
G. A ten dollar (\$10.00) application fee made payable to "Williamson County Bail Bond Board" and deliverable to the Williamson County Treasurer.
H. Proof of completion of at least eight hours of continuing legal education in criminal law courses or bail bond courses approved by the State Bar of Texas and offered by an accredited institution of higher education in the state.
I. Submit documentary evidence that, in the two (2) years preceding the date this application is filed, the Applicant has been continuously employed by a person licensed under this chapter for at least one year and for not less than 30 hours per week, excluding annual leave, and has performed duties that encompass all phases of the bonding business.
J. Corporate Agents are required to have the following:
