Behind the Scenes of



Williamson County is one of 254 counties in Texas. County government is a political subdivision of the state, and as such, implements state policies and laws. They also deliver many state services at the local level, while keeping the local county tax rate as low as possible.

Williamson County has several departments that work hard behind the scenes to ensure that Williamson County is fiscally responsible with purchases and spending. These departments include the Budget Office, Purchasing Department, County Auditor and the County Treasurer. Each of these departments has a unique and important role to play in how Williamson County operates.

BUDGET OFFICE

It all starts with the Budget Office. They diligently prepare the proposed county budget in conjunction with the County Auditor. The Auditor's Office has responsibility for projecting revenue, while the Budget Office projects expenditures. The proposed budget is then presented to the Commissioners Court for revisions and eventual adoption.

PURCHASING DEPARTMENT

Once the budget for the fiscal year is set, the Purchasing Department helps county offices and departments purchase goods and services essential to the operation of Williamson County. This includes making sure purchases are in compliance with the Texas Local Government Code.

COUNTY AUDITOR

The County Auditor is responsible for the oversight of all the financial books and records of county officials and adheres to strict enforcement of all laws governing county finances. They also audit the records and accounts of the county offices and departments. To avoid any conflict, the County Auditor is appointed by the District Judges.

COUNTY TREASURER

The County Treasurer acts as the county's banker. This office receives and deposits all county revenues and serves as chief liaison between the county and the bank depository. The Treasurer also is charged with investing of county funds.

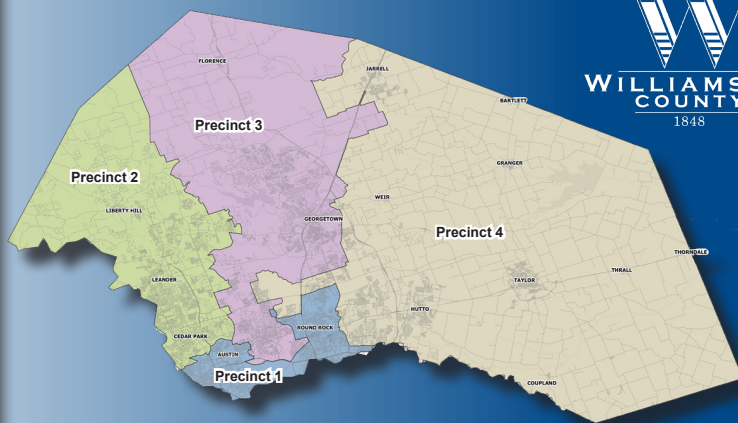

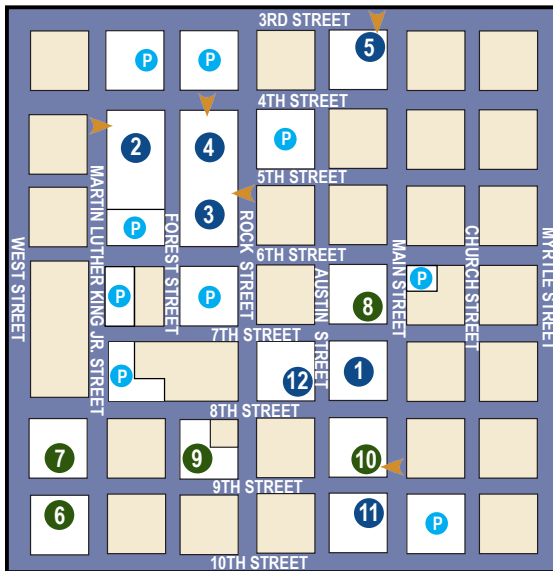
