- 2. OLD BUSINESS UPDATE: Treasurer reported that a \$50,000 CD for Lone Star Bail Services was received by his office on February 12, 2018. Corporate Surety and Corporate Agent's License Applications were conditionally approved in the January 19 meeting pending receipt of CD. Approval effective date is from 2/12/2018 to 2/11/2020.

- 9. The Board moved to authorize the Secretary of the Board to pay final judgments in accordance with Section 1704.204(b), Texas Occupations Code after a motion by Bridget Chapman and a second by Judge Kennon. The motion carried unanimously.

It was discussed and agreed to appoint the Bail Bond Secretary as the authorized representative of the Board to notify the Sheriff of unpaid final judgments in accordance with Section 1704.2535, Texas Occupations Code. Approved after a motion by Bridget Chapman and a second by Judge Kennon. The motion carried unanimously.
- 11. Continuous Improvement update: Bridget Chapman and Scott Heselmeyer continue to work on updating the rules. Bridget Chapman reported that there is a new Local Agreement between the Bail Bondsmen and the District Attorney. Most Bail Bondsmen have signed the Agreement.
