I have not taken a Driver's Safety Course in the past 12 months nor am I currently in the process of taking the course for a different offense. My driver's license is valid and is not suspended. My offense is NOT one of the following:

- a) Any offense in a work zone with workers present
- b) Speeding 25 MPH or more over the limit, or at a speed of 95 MPH or more
- c) Passing a school bus that was loading/unloading children
- d) Failing to remain at the scene of an accident involving vehicle damage or injury to a person, or failing to render aid or exchange information after such accident.

I am not a CDL holder nor do I have a CDL permit currently or at the time of the offense.

I understand the following:

- a) Per the Texas Code of Criminal Procedure, Article 45.0511(g), a defendant who requests but does not take the course is not entitled to a refund of the fee and costs.
- b) If I fail to take the course, I will be required to appear before the Court and show good cause why I failed to comply. If good cause is not found, the Court shall enter an adjudication of guilt and impose a sentence on this offense, and a conviction for this offense will be added to my driving record.
- c) I must complete and submit to the Court an official, signed certificate of a Driver's Safety Course and a copy of my Type 3A Driving Record maintained by DPS within 90 days of my deferred judgment.
